**Sub:** Inviting Intent from Training Providers for Empanelment with ASDM to implement NBCFDC sponsored skilling program 2020-21.

This is reference to 1<sup>st</sup> phase target received by ASDM for Short Term Training (STT) and Up-skilling (RPL) from National Backward Classes Finance and Development Corporation (NBCFDC) for FY2020-21. ASDM, hereby, invites intent from Training Providers meeting with the following criteria to implement NBCFDC sponsored skilling program 2020-21:

1. The Training Providers (TP) should have been active and operational in the field of Skill Development and vocational training for a minimum of three years..
2. The Training Providers should have a total turnover of ₹ 30 lakhs or more in the past three consecutive years. The organization is required to submit a copy of audited financials for the last three years along with Certificate for Turnover of the organization issued by the Chartered Accountant."
3. The Training Providers should have experiences in conducting skill trainings of National Backward Classes Finance and Development Corporation / National Schedule Castes Finance and Development Corporation and as proof sanction order may be attached.
4. The Training Providers should have Job role well equipped centre as per SSC norms.

5. The Training Providers should have SSC certified trainers for conducting the above trainings (attach proof).
6. The training to be conducted as per guidelines outlined in NBCFDC sanction order (attach undertaking in letter head of TP).
