1. Overview of ASDM

Assam Skill Development Mission (ASDM) is registered under Society Registration Act, 1860 in 2015 and is working under the aegis of Skill, Employment & Entrepreneurship Department (SEED), and Government. The Mission started functioning from January, 2017 as an apex body of all skill activities in the state to achieve skilling and gainful employment for the youth of the state. ASDM also aims at creating a sustainable skill ecosystem for convergence of quality skills training and also encourage budding entrepreneurs in different sectors. ASDM is implementing the state-funded Placement linked Skill Development Training Programme and Centrally-funded Pradhan Mantri Kaushal Vikas Yojana for providing short term training on various skills which are in high demand. Further, ASDM has established state of the art North East Skill Centre in collaboration with ITEES, Singapore which provides one-year certificate courses in the sectors of Beauty & Wellness, Hospitality, Housekeeping, Food and Beverage Service and Retail Services. Further, more, ASDM is also implementing the establishment of the first of its kind in the entire region the Assam Skill University with financial assistance from Asian Development Bank(ADB).

1.1 Project Overview:

This project (Entrepreneurship Development & Sustainable Livelihood Generation for State of youth in Assam through Training & Enabling last mile delivery of repair and maintenance for Electric 3 Wheeler L5 Vehicle) is approved under Skill Acquisition and Knowledge Awareness for Livelihood Promotion (SANKALP), Ministry of Skill Development & Entrepreneurship (MSDE), Govt. of India and tender documents are designed based on the guideline issued by MSDE and any changes in guidelines in future to be followed for implementation of the project.

The training location will be at Kamrup (Metro) and at least one training center in the border areas of Assam. The candidates/trainees are to be mobilized from rural areas of the State and preferably from the Border areas of Assam (bordering areas with the states namely Meghalaya, Arunachal Pradesh, Manipur, Mizoram, Nagaland, Tripura, West Bengal) targeting 500 unemployed youth in the age group of 18-40 yrs. The training programme will be fully residential.

The aim of the project is to empower the local workforce in Assam and create employment opportunities in the emerging field of electric mobility. By providing specialized training on Electric Vehicles (EVs), the project aims to benefit both the individual's seeking employment and the state's overall goal of promoting sustainable transportation.

Key Objectives of the projects are as under:

- **Skill Development:** The primary objective of EV training is to develop a skilled workforce that is proficient in handling the installation, maintenance, and repair of electric vehicles. This includes training individuals on the technical aspects of EV components, battery systems, electric motors, charging infrastructure, and diagnostic tools. By enhancing the skill set of professionals, Assam can meet the demands of the evolving EV industry and ensure the smooth operation of electric vehicles in the state.
- **Promote Safety:** Electric vehicles are powered by high-voltage batteries, and working with such electrical systems requires specialized knowledge and training. One of the objectives of EV training is to prioritize safety and educate professionals on the safe handling, maintenance, and troubleshooting of EVs. This includes imparting knowledge about electrical safety protocols, handling hazardous materials, and emergency response procedures. By ensuring the safety of both vehicle occupants and service technicians, EV training contributes to building a secure environment for the EV ecosystem.
- Awareness and Public Outreach: Promoting awareness and outreach programs is another key
 objective of EV training in Assam. This involves conducting workshops, seminars, and public

campaigns to educate the general public about the benefits of electric vehicles, charging infrastructure, and sustainable transportation. EV training programs can equip individuals to answer queries, clear misconceptions, and promote EV adoption, thereby creating a positive perception of electric mobility among the masses.

Collaboration and Networking: EV training aims to create a network of professionals, organizations, and institutions working in the electric vehicle field. This objective emphasizes collaboration between academia, industry, and government bodies to facilitate placement and entrepreneurship in the EV sector, knowledge exchange, best practices sharing, and joint initiatives. By fostering collaboration, EV training can contribute to the overall growth and development of the EV ecosystem in Assam.

Overall, the objectives of EV training in Assam encompass skill development, safety promotion, and awareness creation. These objectives collectively aim to build a sustainable and thriving electric vehicle industry in the state, contributing to job creation for the youths, economic growth, environmental protection, and a cleaner future.

2. Scope of Work.

- 2.1 Training partners shall impart the training at the designated Training Centers across Assam.
- 2.2 Preference may be given to the Training Partners those who are empaneled with ASDM.
- 2.3 Preference may be given to the Training Partners those who have experience in skilling Electric Vehicle Service Technician and Light Motor Vehicle Driver
- 2.4 Mobilizing candidates for skill training.
- 2.5 The trainers should meet the minimum qualification criteria as required for the respective Qualification Packs. Also, the eligible trainer should be Training of Trainer (ToT) certified as per the concerned Sector Skill Council (SSC) norms.
- 2.6 Facilitating assessment of candidates on completion of training curriculum through concerned Sector Skill Councils duly affiliated by Ministry of Skill Development & Entrepreneurship (MSDE).
- 2.7 The applicant should submit employment strategy for both self and wage with the tender document.
- 2.8 The Training Provider will provide all the necessary post training support for wage and selfemployment of the successfully trained candidate.
- 2.9 Post placement tracking of the candidates to be done.
- 2.10 The training duration per day shall be 8 hours per day (fully residential). Non-residential training centres will not be allowed under any circumstances.
- 2.11 Training Partner needs to provide the equipment's for the training at the premises.
- 2.12 The maximum batch size will be 30 beneficiaries; the minimum batch size will be 20.
- 2.13 The training duration of the project shall be as per the Qualification Pack (QP) of the Job role as notified by the concerned Sector Skill Council (SSC).
- 2.14 A candidate should have at least 70% attendance to be eligible to appear for Assessments.
- 2.15 Biometric attendance duly verified by District Project Manager-Training (DPM-T) or ASDM officials and the Training Partner to be submitted during submission of invoices.
- 2.16 Assessment and certification shall be done by concerned Sector Skill Council (SSC) through appointed assessment agencies.

- 2.17 The target will be allocated based on job roles mentioned in Annexure-I.
- 2.18 The implementation Partner/Training Partner will be responsible for the on-ground planning, management and implementation of various activities leading to desired outcome under the project. Implementation Partner/Training Partner will closely work with all stakeholders associated with the project for overall coordination and achievement of the project objectives.
 - I. Implement end to end training programme in the following areas:
 - a. Electric Vehicle Service Technician (ASC/Q1429) -400 Hours (Category-I): 250 beneficiaries to be trained to develop their skills in servicing, repairing and overhauling of electric vehicles.
 - b. Light Motor Vehicle Driver (ASC/Q9702) -304 Hours (Category-I): 250 beneficiaries to be trained to develop their skills in driving and maintenance of Electric Vehicles.
 - II. To organize awareness/orientation sessions on the training program by organizing workshops, seminars, and public campaigns including information dissemination on benefits of electric vehicles, charging infrastructure, and sustainable transportation.
 - III. Collaborate with Indian Institute of Entrepreneurship, Guwahati for candidate mobilization and entrepreneurship training of enrolled candidates.
 - IV. Training Partner to undertake all activities including awareness generation, holistic counseling & trainee mobilization including women and marginalized groups, setting up of training centers, availability of necessary tools and equipment, engagement of certified trainers, quality of training delivery, timely assessment and certification of trainees, placement facilitation/support for self- employment and post placement support to placed trainees.
 - V. Training partner to take initiative to collaborate with agencies/organizations deploying a fleet of Electric Vehicle (EVs) for e-commerce/logistic management and operations, charging and maintenance facilities and other such agencies for providing industry exposure, placement opportunities and creating backward and forward linkages for trainees keen on pursuing self-employment opportunities.
 - VI. Identification and enrollment of beneficiaries from the border states of Assam including setting up of at least one training center in the border areas (bordering areas with the states namely Meghalaya, Arunachal Pradesh, Manipur, Mizoram, Nagaland, Tripura, West Bengal).
 - VII. Provide support in connecting with local banks services and schemes and facilitate financial linkage
 - VIII. To ensure placement and self-employment of trainees.
 - IX. Maintain comprehensive digital MIS of the training program covering all aspects from awareness generation to post placement support.
 - X. Training Partner to Ensure AADHAAR enabled bio-metric attendance of trainees and trainers. TP to provide real time access of the biometric attendance (candidates & trainer) data to ASDM. The batch timing should be communicated to ASDM in advance for spot checking. Also the attendance should be marked with 20 minutes (Plus/Minus) of batch timing and any delay beyond this limits should be considered as absent.
 - XI. One time Mobile OTP verification should also be done at the beginning so that we have correct Mobile number of the candidate.

- XII. No advance shall be provided to the implementing agency for first two batches.
- XIII. Training Partner/Implementing agencies to ensure availability to trainer before starting the project in the identified geographies. The same should be updated on the Skill India Portal (Takshashila) as well.
- XIV. Training Partner/Implementing agencies to ensure assessment and- certification within one week of completion of training program. The digital transcript of the assessment to be shared with both ASDM and the candidate.
- XV. The 3rd batch of training at any location will start only after the successful completion of the 1st batch in line with the mapped outcome.
- XVI. Candidates to be tracked quarterly till a period of one-year post completion of the candidate's training. Implementing agencies/Training Partner to ensure that records for the same are maintained and presented as per requirement of ASDM
- XVII. Candidates who are unable to pass the assessment, despite attending all classes, should be provided remedial classes/ extra classes/ additional assessment as required without any additional cost.
- XVIII. Candidate to have contribution of Rs. 1,000 as security deposit for enrolling themselves for the training programme and it will be refunded post completion of assessment & certification.
 - XIX. Assessment fees as applicable per candidate will be deducted from training partner which will be paid to Sector Skill Council (SSC)
 - XX. The Training Provider will be responsible for candidate mobilization / counselling of candidates and carrying out training, assessment, certification and post certification tracking of the successfully certified candidates.
 - XXI. Submit monthly progress reports and deliverable reports to ASDM upon completion of each payment milestone deliverables defined in the MoU.
- XXII. Also, ASDM shall monitor program performance as per the envisaged monitoring & evaluation framework. The entire task of Program Monitoring and Evaluation shall be conducted through various means including an online Management Information System (MIS) that has been designed, developed and deployed by ASDM.

ASDM reserves the right to accept or reject any proposal, and to annul the tendering process and reject all proposals at any time prior to award of work, without thereby incurring any liability to the affected bidder(s) or any obligation to inform the affected bidder(s) of the grounds for action so taken. Also, ASDM reserves the right to cancel or modify this NIT at any time.

12. Validity Period:

- i. The proposals shall be valid for a period of 180 days from the date of submission of bids. A proposal valid for a shorter period may be rejected as non-responsive. On completion of the validity period, unless the bidder withdraws his proposal in writing, it will be deemed to be valid until such time that the Bidder formally (in writing) withdraws his proposal.
- ii. In force majeure circumstances, at its discretion, ASDM may solicit the bidder's consent for an extension of the validity period. The request and the responses thereto shall be made in writing/email.
- iii. Performance Security of 5 % of Work order to be submitted along with a validity of 3 months after the work completion. MD, ASDM reserves the right to decide the establishment of non-performance by TP.
- iv. This NIT along with the TP Agreement / MoA format is enclosed herewith as Annexure-II and the so issued, form an integral part of the whole tender process and should be read in entirety.

13. Force Majeure

I. Definition:

For the purposes of this Agreement, "Force Majeure" means an event which is beyond the reasonable control of a Party, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial

action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking ForceMajeure to prevent), confiscation or any other action by government agencies.

- II. Force Majeure shall not include insufficiency of funds or failure to make any payment required here under.
- III. For the purposes of this Agreement, "Force Majeure" means an event which is beyond the reasonable control of a Party, and which makes a Party's performance of its obligations here under impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, epidemic, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by government agencies.
- IV. Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or agents employees thereof, nor (ii) any event which adiligent Party could reasonably have been expected to both (A) take into account at the time of the conclusion of this Agreement and (B) avoid or overcome in the carrying out of its obligations here under.
- V. ASDM will decide the eventuality of Force Majeure which will be binding on both the parties.

13.1 No Breach of Agreement:

The failure of a Party to fulfil any of its obligations hereunder shall not be considered to be a breach of, or default under, this Agreement so far as such inability arises from an event of Force Majeure, provided that the Party affected by such an event h as taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Agreement.

- I. Measures to be taken: A Party affected by an event of Force Majeure shall take all reasonable measures to remove such Party's inability to fulfill its obligations hereunder with a minimumof delay. A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible and in any event not later than fourteen (14) Days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give notice of the restoration of normal conditions as soon as possible. The Parties shall take all reasonable measures to minimize the consequences of any event of Force Majeure.
- II. **Extension of Time:** Any period within which a Party shall, pursuant to the Agreement to this NIT, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.
- III. **Consultation:** Not later than thirty (30) days after the TP has, as the r e s u l t of an event of Force M a j e u r e, become unable to perform a material portion of the Services, the Parties shall consult with each other with a view to agreeing on appropriate measures to be taken in the circumstances.

13.2 Notification procedure for Force Majeure: -

- The affected Party shall notify the other Party of a Force Majeure event within seven (7) Days
 of occurrence of such event. If the other Party disputes the claim for relief under Force
 Majeure it shall give the claiming Party written notice of such dispute within thirty (30) days
 of such notice.
- II. Upon cessation of the situation which led the Party claiming Force Majeure, the claiming Party shall within seven (7) days hereof notify the other Party in writing of the cessation and the

Parties shall as soon as practicable thereafter continue performance of all obligations.

13.3 Consultation and duty to mitigate

The affected Party shall, at its own cost, take all steps reasonably required to remedy and mitigate the effects of the Force Majeure event and restore its ability to perform its obligations under this Agreement as soon as reasonably practicable. The Parties shall consult with each other to determine the reasonablemeasures to be implemented to minimize the losses of each Party resulting from the Force Majeure event. The affected Party shall keep the other Parties informed through written communication of its efforts to remedy the effect of the Force Majeure event and shall make reasonable efforts to mitigate such event on a continuous basis and shall provide written notice of the resumption of performance hereunder.

14. Dispute Resolution: -

The parties will try to mutually resolve any disputes as far as practically possible. In case, the dispute could not be resolved mutually, the parties will go for Arbitration.

The place of Arbitration will be at Guwahati only. Also, all legal matters arising outof this agreement will be subject to the jurisdiction of the Hon'ble courts situated at Guwahati only

15. Penalty Clause

That the TP shall commence the work (skill training) not later than 30 days from the date of release of the targets to the TCs in the MIS system of ASDM otherwise the target and the Performance Security shall be forfeited.

16. General Terms and Conditions: -

16.1 Definitions of terms:

In this NIT (as hereinafter defined) the following words and expressions shall have meanings hereby assigned to them except where the context requires otherwise:

- I. "Applicable Law" means the laws and any other instruments having the force of law in India for the time being.
- II. "Training Provider" or "TP" means the training provider which provides skill training and is empaneled by Assam Skill Development Mission.
- III. "Contract Agreement" shall mean the agreement between the ASDM Authority and the TP, duly signed by the parties to the agreement through their authorized representative, for the execution of the work as prescribed in the scope of work of this document and all terms and conditions mentioned here.
- IV. "Day" means calendarday.
- V. "ASDM" means Assam Skill Development Mission (ASDM) that has entered into the contract with the TP.
- VI. "Government" means the Government of India /Assam.
- VII. "Party" means "ASDM" being the First Party or the "Training Provider" being the Second Party, as the case may be, and "Parties" means both of them.
- VIII. Cost & Process Norms will mean the Cost & Process norms as are notified from time to time by ASDM.
- IX. "Services" means the work to be performed by the Training Provider pursuant to this NIT
- X. "Third Party" means any person or entity other than "ASDM" or the "Training Provider".

- XI. "In writing" means communicated in written form with proof of receipt.
- XII. "Programme" means Skill Development Programme of the State of Assam.

16.2 Authorized Representatives:

Any action required or permitted to be taken and any document required or permitted to be executed under this NIT by ASDM or the TP may be taken or executed by the officials as specified hereunder:

- I. Mission Director of ASDM for the First Party.
- II. Authorized person of the TP (Power of Attorney to be submitted as per Annexure..... by the TP).

16.3 Relationship between the Parties:

Nothing contained herein shall be construed as establishing a relationship of master and servant or of principal and agent as between ASDM and the TP. The TP, subject to the Agreement under this NIT, has complete charge of their Personnel performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.

16.4 Notices:

- I. Any notice, request or consent required or permitted to be given or made pursuant to the contract shall be in writing. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent by registered post to such Party at the address specified in the Contract.
- II. The 2nd Party may change its address or Its training center address only with due approval of ASDM hereunder by giving the notice in writing of such change or in the case of ASDM, if notified vide a notification/ office order/ circular and displayed on the website.

16.5 Location:

The selected Training Partner should feed (Latitude & Longitude) the exact location in the MIS system as per the issued Work Order. In case, for any change of address, approval needs to be taken from ASDM authority.

16.6 Taxes and Duties:

- I. The TP shall be responsible for meeting all tax liabilities arising out of the Contract or in the course of provision of its services.
- II. The income tax etc., if applicable, shall be deducted at source from the payment to the TP as per the law in force at the time of payment.

16.7 Fraud and Corruption

It is ASDM's policy to require that ASDM as well as TP should observe the highest standard of ethics during the execution of the contract. Neither ASDM nor the TP shall engage in any corrupt, fraudulent, coercive or restrictive practices during the term of the Contract or any extension thereof.

In pursuance of this policy, for the purpose of this provision, the terms are set forth herein below:

 "Corrupt practice" means the offering, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the selection process or in contract execution;

- II. "Fraudulent practice" means a misrepresentation or omission of facts in order to influence a selection process or the execution of the contract;
- III. "Coercive practices" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process, or affect the execution of the contract;
- IV. "Restrictive practice" means forming a cartel or arriving at any understanding or arrangement among organizations with the objective of restricting or manipulating a full and fair competition in the selection process or the execution of the contract.

17. Suspension:

ASDM may, by written notice of suspension to the TP, without any obligation (financial or otherwise) suspend all the payments to the TP hereunder if the TP shall be in breach of the Agreement or shall fail to perform any of its obligations under the Agreement, including the carrying out of the Services; provided that such notice of suspension:

- I. Shall specify the nature of the breach or failure, and
- II. Shall provide an opportunity to the TP to remedy such breach or failure within a period not exceeding thirty (30) days after receipt by the TP of such notice of suspension. The above action will be taken by ASDM as and when deemed fit.
 - In case of non-fulfillment of the terms of this Agreement, ASDM reserves the right to suspend or terminate the agreement, forfeit the Performance security, recovery of the payments or installments released to the concerned TP and may also Blacklist the TP in case of malpractices.
- III. Inspection of TP's training centers will be monitored, supervised and evaluated as per Standard Operating Procedures of ASDM.

18. Termination for Default:

ASDM may, without prejudice to any other remedy for breach of Agreement, by a written notice of default of at least 30 days sent to the TP, terminate the Agreement in whole or in part. The reasons for termination shall include but not limited to the following cases:

- I. If it is discovered at any stage that the TP has been furnishing false claims or providing misleading information with respect to enrolment of trainees, conduct of training or any other aspect related to the programme.
- II. If the TP, in the judgment of ASDM, is found to be engaged in corrupt, fraudulent, coercive and restrictive or collusive practices in competing for or in executing the Agreement.
- III. If the TP commits breach of any condition of the Agreement.
- IV. If the TP is dis empaneled at any stage during the course of the Agreement.
- V. The TP fails to comply with any final decision reached as a result of arbitration proceedings;
- VI. The TP fails to comply to the decisions of the ASDM;
- VII. The TP submits to ASDM a statement which has a material effect on the rights, obligations or interests of ASDM and which the TP knows to be false;
- VIII. As the result of Force Majeure, the TP is unable to perform a material portion of the Services beyond the stipulated time, even after giving ample opportunities by ASDM. MD, ASDM reserves the right to decide on the time frame and number of opportunities to be given to the TP.
- 18.1 Termination for Insolvency- ASDM may at any time terminate the Agreement by giving a

notice of at least 30 days to the TP, if the TP becomes bankrupt or otherwise insolvent. In such event, termination will be without compensation to the TP, provided that such termination will not prejudice or affect any right of action or remedy that has accrued or will accrue thereafter to ASDM.

- **18.2 Termination for Convenience** ASDM, by a written notice of at least 30 days sent to the TP, may terminate the Agreement, in whole or in part, at any time for its convenience. The Notice of Termination shall specify that termination is for ASDM's convenience, the extent to which performance of the TP under the Agreement is terminated, and the date upon which such termination becomes effective.
- **18.3 Cessation of Rights and Obligations and Services**: Upon termination of this Agreement or upon expiration of this Agreement, all rights and obligations of the Parties hereunder shall cease, except;
 - I. Such rights and obligations as may have accrued on the date of termination or expiration,
 - II. The obligation of confidentiality,
 - III. The TP's obligation to permit inspection, copying and auditing of its accounts and records by ASDM.

Upon termination of this Agreement by notice of either Party to the other Party, the TP shall immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every able effort to keep expenditures for this purpose to a minimum.

19. Batch extension and invoice submission timelines, Recovery.

Batch date extension will be allowed only one-time subject to submission of valid justification for extension by TP and acceptance of the same by MD, ASDM.

The TP should raise 1st installment bill within one month (30 days only) of batch start date, 2nd installment bill within one month (30 days only) of declaration of result of a particular batch and 3rd installment, within one month (30 days only) of the completion of the batch cycle, i.e. of completion period of three (3) months post placement of the candidates. Beyond the prescribed time limits, bills will be rejected. Also, recovery of amount disbursed to the TP will be initiated if the TP fails to claim 2nd installment within the time limit and/or for the failed candidates in the assessment process. Hostel invoices should be raised within 30 days from assessment of the candidates of the concerned batch or else the invoice generation will be blocked.

20. Forfeiture of Performance Security: Performance Security will be forfeited for the TPs not completing the full life Cycle of the training program as per defined timeline.

The PS submitted by the TP can be forfeited in the following cases:

- I. If the TP is dis empaneled for any reason.
- II. If the TP does not start training of candidates within 30(Thirty) days of receiving the workorder.
- III. If the contract is terminated for default or insolvency.
- IV. Any other case, if the ASDM so decides.

21. Fairness and Good faith

Good Faith: The Parties undertake to act in good faith with respect to each other's rights under this Contract and to adopt all reasonable measures to ensure the realization of the objectives of this Contract.

Operation of the Contract: The Parties recognize that it is impractical in this NIT to provide for every contingency which may arise during the life of the Contract, and the Parties hereby agree that it is their intention that this Contract shall operate fairly as between them, and without detriment to the interest of either of them, and that, if during the term of this Contract either Party believes that this Contract is operating unfairly, the Parties will use their best efforts to agree on such action as may be necessary to remove the cause or causes of such unfairness.

As far as possible, any disputes between the parties shall be amicably solved with mutual understanding and written consent by both the parties.

22. Books and Records

A Training Provider shall maintain a separate Bank Account for receiving payments from ASDM and incurring all expenditure relating to the scheme.

A Training Provider shall have to maintain proper books and records of the Receipts and Payments in the form of Cash Book, Cheque issue register, vouchers for expenditure etc.

23. Mutual rights and obligations

The mutual rights and obligations of ASDM and the TP shall be as set forth in the Contract, in particular:

The TP shall carry out and complete the Services in accordance with the provisions of the Contract; and ASDM shall make payments to the TP in accordance with the provisions of the Contract, cost norms and process norms after making relevant deductions and conduct of due diligence and audit.

24. Safety regulations

In respect of all the trainers and trainees engaged by the TP directly or indirectly involved in the work for the performance of TP's part of this Agreement, the TP shall at his own expenses arrange for all thesafety provisions as per the applicable laws in force.

25. General rules

Smoking, consumption of tobacco/alcohol or use of any abusive substances by any trainer and trainees and any personnel engaged by the TP within the entire area of the training center and in the institute campus in general are strictly prohibited. Violators of this rule shall be prosecuted as per law and discharged immediately from the training. Security and appropriate behavior towards trainees should betaken care of by the TP/TC.

26. Interpretation

If the context so requires, singular means plural and vice versa

Any waiver of a Party's rights, powers or remedies under the agreement must be in writing, dated and signed by an authorized representative of the party granting such waiver and must specify the right and the extent to which it is being waived.

Subject to the conditions of the above clause, no relaxation, forbearance, delay or indulgence by either party in enforcing any of the terms and conditions of the agreement or the granting of time by either parties to the other shall prejudice, affect or restrict the right of that party under the agreement, neither shall any waiver by either party of any breach of agreement operate as waiver of any subsequent or continuing breach of agreement.

Severability: If any provision or condition of the agreement is prohibited or rendered invalid or unenforceable, such prohibitions, invalidity or unenforceability shall not affect the validity or

Enforceability of any other provisions and conditions of the agreement.

27. Governing law

The Agreement shall be governed by and interpreted in accordance with the laws of the Assam State/The Country (India).

28. Jurisdiction

The Parties to the agreement hereby submit to the jurisdiction of the Hon'ble Courts situated at Guwahationly for the purpose of actions and proceedings arising out of this contract.

29. Amicable settlement:

In case of dispute between the parties regarding any matter under the contract, either Party of the contract may send a written Notice of Dispute to the other party. The Party receiving the Notice of Dispute will consider the Notice and respond to it in writing within 30 days after receipt. If that party fails to respond within 30 days, or the dispute cannot be amicably settled within 60 days following the response of that party, the Parties may go for Arbitration.

30. Arbitration:

In the case of dispute arising upon or in relation to or in connection with the contract between ASDM/Authority and the TP, which has not been settled amicably, any party can refer the dispute for Arbitration under (Indian) Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be conducted by the sole arbitrator. The Arbitration and Conciliation Act, 1996 and any statutory modification or re-enactment thereof, shall apply to these arbitration proceedings. The decision of the arbitrator shall be final and binding upon both parties and the parties agree to be bound thereby and act accordingly. The Arbitration proceedings shall be held in Guwahati, Assam only.

The limitation period for referring the dispute to the Arbitrator will be 90 days from the first instance of dispute.

31. Payment Terms

Training fees payments would be released as per updated cost and process norms document released by ASDM from time to time.

ASDM shall disburse the payment after all due verifications have been done for the submitted documents as required against each installment which has been defined in the cost and process norms as updated from time to time. Also, the TP has to claim bill for each of its installments within time limits prescribed of the necessary process of training for that installment. No bill will be received beyond that period for the respective installment of the concerned TP as mentioned in this agreement.
